The National Oil Shale Association (NOSA) is a non-profit organization dedicated to oil shale education. We are not a lobbying organization. Our mission is to educate the public, media, elected officials and other organizations about the facts surrounding oil shale and its potential for supplementing the supplies of petroleum and transportation fuels in the United States. We advocate the responsible development of oil shale.

Any firm, organization or individual is eligible for membership if it supports the mission of NOSA. The benefits of membership include access to current information on oil shale via a variety of on line communications and through participation in association activities.

NOSA is seeking members in two classes of membership: Sustaining Members and Associate Members. Sustaining Members shall have the right to vote, serve as Board members, elect Board members and receive certain other benefits determined by the Board. Associate Members shall be individuals or organizations and they are non-voting members. Associate Members shall not be for profit corporations, divisions of corporations, firms, partnerships, or other such groups in business to make a profit. Associate Members may not serve as Board members. Associate members shall be classified as Individuals or Non-profits.

Dues and Fees are as follows: Sustaining Members - \$4,000 one time initiation fee and \$2,000 per year annual dues. Sustaining Members may pay the initiation fee in four annual installments of \$1,100. Individual Associate Members - \$100 per year annual dues (no initiation fee). Non-profit Associate Members—\$1,000 per year annual dues (no initiation fee).
